### Inhalation

### **Eye Contact**

Rinse eyes cautiously with lukewarm, gently flowing water for several minutes, while holding the eyelids open. Remove contact lenses, if present and easy to do. Continue rinsing for a duration of 15-20 minutes or until medical aid is available. If irritation occurs, cautiously rinse eyes with lukewarm, gently flowing water for 5 minutes, while holding the eyelids open.

### **Skin Contact**

Take off contaminated clothing, shoes and leather goods (e.g. watchbands, belts). Rinse/wash with lukewarm, gently flowing water and mild soap for 5 minutes or until product is removed. ## **SECTION 5) FIRE-FIGHTING MEASURES**

### **Suitable Extinguishing Media**

Small Fire : Dry chemical, foam, carbon dioxide, water-spray or alcohol-resistant foam. Carbon dioxide can displace oxygen. Use caution when applying carbon dioxide in confined spaces. Large Fire: Water spray, fog or alcohol-resistant foam.

### **Unsuitable Extinguishing Media**

Do not use straight stream of water.

## **SECTION 6) ACCIDENTAL RELEASE MEASURES**

### **Emergency Procedure**

Isolate hazard area and keep unauthorized personnel away. Stay uphill and/or upstream. Do not touch damaged containers or spilled materials unless wearing appropriate protective clothing. Ventilate closed spaces before entering.

### **Recommended Equipment**

Wear chemical protective clothing.

### **Personal Precautions**

Avoid breathing vapor or mist. Avoid contact with skin, eye or clothing.

### **Environmental Precautions**

Stop spill/release if it can be done safely. Prevent spilled material from entering sewers, storm drains, other unauthorized drainage systems and natural waterways by using sand, earth, or other appropriate barriers. Dike far ahead of liquid spill for later disposal.

### **Methods and Materials for Containment and Cleaning up**

Absorb Liquids in vermiculite, dry sand, earth, or similar inert material and deposit in sealed containers for disposal.

## SECTION 7) HANDLING AND STORAGE

### General

Wash hands after use. Do not get in eyes, on skin or on clothing. Do not breathe vapors or mists. Use good personal hygiene practices. Eating, drinking and smoking in work areas is prohibited. Remove contaminated clothing and protective equipment before entering eating areas. Eyewash stations and showers should be available in areas where this material is used and stored. All containers must be properly labeled.

### Ventilation Requirements

Use only with adequate ventilation to control air contaminants to their exposure limits.

### Storage Room Requirements

### Skin Protection
